NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and all other powers hereunto enabling the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh State and Subordinate Service Rules, 1996, issued in G.O.Ms.No.436 G.A.(Ser.D) Department dated 15th October, 1996 and as subsequently amended from time to time.

2. The amendments hereby made shall be deemed to have come into force with effect from 14.02.2003.

AMENDMENTS

In the said rules,-

I.(1) In rule 6(b), the following shall be inserted as first proviso, namely,-

"Provided that for promotion in respect of Scheduled Caste and Scheduled Tribe candidates only, the zone of consideration in the ratio of 1:3, shall not be applicable in respect of posts whose total cadre strength is more than five"

er inserting the above proviso,

In the second proviso, for the words "provided at" the words "provided further that" shall be obstituted.

In the third proviso, for the words "provided further that" the words "provided also that" shall be substituted.

n rule 22,-

1) for clause (ii) of sub-rule (1) the following shall be substituted, namely,-

(ii) "otherwise than by direct recruitment the principle eservation in the matter of promotion and appointment by sfer involving promotion in so far it relates to Scheduled tes and Scheduled Tribes only shall apply to such services, as or Category whose total cadre strength of the post is the than five".

(2) for ,sub-rule 2(a) ,the following shall be substituted, nely,-

2(a) The unit of appointment for the purpose of direct uitment shall be hundred vacancies of which fifteen shall be rved for Scheduled Castes, six shall be reserved for eduled Tribes, twenty five shall be reserved for Backward sses and the remaining fifty four appointments shall be le on the basis of open competition and subject to rule 22-A nese rules.

2(a)(i) The unit of appointment for the purpose of rvation in the matter of promotion and appointment by sfer involving promotion shall be hundred vacancies of ch fifteen shall be reserved for S cheduled Castes and six Scheduled Tribe employees as per the roster points in Sub-2(e).

In the case of appointments/promotions to the posts referred to in clause 2(a)(i) above, the panels of eligible candidates for promotion, the names of eligible Scheduled Caste and Scheduled Tribe employees from the feeder Category have to be shown against the roster points earmarked for them irrespective of their seniority position in the feeder category.

b. If a Scheduled Caste and Scheduled Tribe employee gets a higher place in the eligible candidates list by virtue of his seniority in the feeder category he need not be adjusted in a lower position which is carmarked for an Scheduled Caste and Scheduled Tribe employees as per roster system. Such roster point has to be filled up by moving up an Scheduled Caste and Scheduled Tribe employees who is below in the seniority list in the feeder category.

C. Filling up the roster points shall continue till the required percentage of Scheduled Caste and Scheduled Tribe candidates is obtained. Once the required percentage is obtained by taking into a ccount b oth the Scheduled Caste and Scheduled Tribes candidates who are found in the list of candidates fit for promotion on account of their seniority in the feeder category and those who are moved up to fill up the required roster point, further adjustment of Scheduled Caste and Scheduled Tribe employees against roster point has to be stopped.

- D. Unutilised roster points after the required Scheduled Caste and Scheduled Tribes percentage is met, shall lapse.
- E. If required number of Scheduled Caste and Scheduled Tribe employees are not available in the feeder category to obtain the required representation in the promotion category. The vacancies earmarked for Scheduled Caste and Scheduled Tribe employees according to the roster points will be carried forward.
